National Environment Policy Act (NEPA)

- Signed into Federal law in 1970
- Establishes a national environmental policy and provides a framework for environmental planning and decision-making by Federal agencies
- Procedural statute that directs Federal agencies, when planning projects or issuing permits, to conduct environmental reviews to consider the potential impacts on the environment by their proposed actions
- NEPA applies to all Federal agencies and their "actions"



What Does NEPA Apply To?

- The NEPA statute applies to a broad range of Federal government "actions," including:
 - Providing Federal **funds** to public and private projects
 - Issuing Federal permits/licenses/approvals
 - Issuing Federal regulations and policies
 - Making Federal land management decisions
 - Other Federal undertakings that may result in the potential for significant environmental impacts



More Than Just NEPA?

 Federal agencies typically use the NEPA process to consider and address dozens of additional statutes, regulations, executive orders, and requirements



Three Types of NEPA Classes of Action

- 1. Categorical Exclusion (CE)
 - Types of actions known to not have significant environmental impacts
- 2. Environmental Assessment / Finding of No Significant Impact (EA/FONSI)
 - Used to determine if an EIS is needed or to document that there are no significant impacts, leading to FRA issuing a FONSI
 - Public comment period
- 3. Environmental Impact Statement & Record of Decision (EIS/ROD)
 - Significant environmental impacts
 - Most extensive and in-depth environmental review
 - Public involvement throughout the process



NEPA Process





FRA Environmental Regulations and Procedures

- In 2018, FRA joined sister agencies, the Federal Transit Administration (FTA) and the Federal Highway Administration (FHWA), in their environmental procedures, creating consistency and more streamlined reviews between FRA, FHWA, and FTA
- FRA NEPA regulations can be found in 23 CFR 771
- FRA has identified <u>22 categories of</u> <u>actions/activities</u> in 23 CFR 771.116 that have been determined to have no significant impacts and do not require an EA or EIS

Key Things To Know for Project Development (Not Just for CEs)

- Project purpose and need
- Project function (i.e., grade separation, rail upgrades/track and tie, bridge updates)
- Project location
 - Is your project in a floodplain or historic district?
 - Is your project within a railroad right-of-way?



NEPA at FRA

Where should I begin if I have a proposed or funded project?

- Ask questions and coordinate with FRA environmental specialists
- Work with FRA—we are your Federal partner





NEPA at FRA

Is my proposed project a CE?

- Does your project fit within one of <u>22 categories of</u> <u>actions/activities</u> in 23 CFR 771.116?
- Are there any unusual circumstances that would kick your project out of consideration for a CE?
- FRA projects may also use categorical exclusions specific to sister agencies FTA and FHWA



Examples of FRA CEs

- Planning
- Positive Train Control
- Track, tie, ballast replacement
- Minor rail line additions
- Property acquisition
- Bridge rehabilitation
- Emergency repairs

- Construction of small structures, e.g., a passenger platform

How to Prepare Documentation for FRA's Categorical Exclusion (CE)

- Get to know FRA's <u>CE Worksheet</u>
 - Project purpose and need
 - Brief project description
 - NEPA study area map showing the project footprint
 - Short summary of resources
 - Potential project impacts specific to your project area
 - Include commitments to project design and other measures to minimize or eliminate impacts, if known
 - Include attachments (or incorporate by reference, where possible) of any technical memoranda or reports supporting the document



Tips and Tricks

- Use <u>FRA's Categorical Exclusion</u> <u>Companion Guide</u> to help complete the FRA CE Worksheet for the resources present within your project area
- The environmental issues encountered for a CE should be minimal and should only be those resources that apply to the project under consideration
- Use free online mapping tools to identify environmental resources within your project footprint





Tips and Tricks

- Incorporate past NEPA documentation if you can, or supplement an existing NEPA document to reflect a new project
- Make NEPA documents readable, concise, and straightforward
- Understand documentation and consultation requirements
- Limit the length of NEPA documents—include only information that is essential to making a reasoned choice among alternatives

FRA will verify and approve NEPA once all documentation requirements are met
