

8.0 EIR/EIS Distribution

The distribution of the Draft Fresno to Bakersfield Section Draft EIR/EIS emphasizes the use of electronic media to ensure cost-effective, broad availability to the public and interested parties. The entire Draft EIR/EIS, appendices, and supporting reports are available on the California High-Speed Rail Authority's web site (www.cahighspeedrail.ca.gov/). The Draft EIR/EIS is also available at the repositories listed below. Electronic copies of the document are available on compact disc upon request at the office of the California High-Speed Rail Authority, 925 L Street, Suite 1425, Sacramento, CA 95814.

All persons, agencies, and organizations listed in this chapter have been informed of the availability of, and locations for obtaining, the Draft EIR/EIS, as well as the timing of the 45-day formal comment period. Notice of availability of the Draft EIR/EIS has been included in the Federal Register. This document also serves as the U.S. Army Corps of Engineers' notification about the availability of the application for an Individual Permit under Section 404 of the Clean Water Act. Repositories and cooperating federal agencies were sent both hard and electronic copies of the Draft EIR/EIS and appendices. Other federal agencies, state agencies, and selected interested parties listed below have received summary chapters and electronic copies of the Draft EIR/EIS. Federal, state, and county elected officials, mayors of cities with possible stations, and the potentially affected local agencies listed below were mailed an informational brochure and instructions on how to obtain a copy of the Draft EIR/EIS.
